## 1. Summary.

1.1 To consider forfeiting the fee for the staging of the Turkey-Syria Earthquake Appeal in the Town Hall.

## 2. Background.

- 2.1 Llangollen Operatic Society, Llangollen Twenty Club and The Collen Players are combining their considerable talents to stage Llangollen on Show for Turkey and Syria at Llangollen Town Hall over two nights on Thursday and Friday, May 11 and 12.
- 2.2 All proceeds will go to support the Disaster Emergency Committee in which fifteen of the UK's top charities have come together to supply a lifeline to thousands of survivors of the earthquake which devastated southern and central Turkey and northern and western Syria on February 6
- 2.3 In addition to the contributions made by the performers a number of local businesses have pledged their financial support and it would be appropriate if the Town Council supported the event by providing free use of the Town Gall over the two nights thus saving the fundraisers £180 in hire charges.

## 3. Recommendations.

3.1 It is recommended that the Asset Management Committee waives the fees for the staging of the Turkey-Syria Earthquake Appeal Concert to be held on the 11 and 12 May.

## 5. Reason for recommendations.

To support local initiatives that support raise funds for the Disaster Emergency Committee charities and their local partners providing urgent aid to southern Turkey and northwest Syria.

## 1. Summary.

1.1 To confirm the number of planters to be purchased.

# 2. Background.

- 2.1 At the Asset Management Committee resolved to purchase Kirkholt Planters manufactured by Broxap, The planters are constructed using Hardwood Iroko FSC® timber with a galvanized which can be made to match the existing stainless-steel brackets of the seating. In January, the quotations from Broxap were pending and therefore cost will determine the number of planters that can be purchased within available budgets.
- 2.3 However following the Committee, the Town Clerk made an. application to the Open Spaces Commuted Sum fund managed Denbighshire County Council's Community Development Team and has been successful in securing £1,238.21 for what has been called Llangollen Town Council's Planters for pollinators project.

#### 3. Planters

3.1 The costs are now available and are detailed below.

3.2 The purchase of one large planter and two square planters would compensate for the loss of capacity created by the decision not to provide hanging baskets and can be positioned on the square to provide more protection from unauthorised vehicular use.
