Individuals asked for the Town Council's support to lobby Denbighshire County Council to prevent the closures. The Deputy Mayor noted the sentiments of the individuals who spoke on this matter and assured them that the Town Council were as equally concerned and would be opening a dialogue with the County Council as a matter of urgency.

Policy RD 3 – Extensions and alterations to dwellings: the proposal represents an over development of the site.

**Planning correspondence.**

Schedule 1b: publicity and consultation: The Royal Hotel, Llangollen.

Members considered the pre planning application and were concerned at the loss of hotel bed spaces and the potential effect on the local tourist economy, but equally recognised the difficult financial position facing the hospitality sector post pandemic.

It was proposed, seconded, and resolved to agree that the alteration of part of the hotel to residential apartments could be acceptable providing the developers can demonstrate to the Local Planning Authority that the retention of the hotel bed spaces is no longer financially viable.

Members also had concerns about aspects which were not covered in any of the documentation attached with this consultation in respect of parking provision and the lack of facilities to house domestic waste recycling with the advent of the Trolibocs system in across Denbighshire, which they felt needed to be addressed. All agreed.
