**Public Consultation Denbighshire's Public Toilet Needs Assessment.**

Ystyriodd yr Aelodau ymateb i ymgynghoriad Cyngor Sir Ddinbych ar Asesiad Anghenion Toiledau Cyhoeddus ac roeddent yn ymwybodol o ganlyniadau'r ddadl yn y Cyfarfod Cymunedol a gynhalwyd ar 6 Awst 2024 gyda mwyafrif clir iawn o deimlad cyhoeddus yn ddymuniad iddynt weld darpariaeth Toiledau Cyhoeddus yn Llangollen yn aros fel y mae.

Cynigiwyd a phenderfynwyd anfon sylwadau ymlaen at Gyngor Sir Ddinbych fel ymateb ymgynghoriad y Cyngorau Tref cyn 15 Medi 2024.

Members consider a response to Denbighshire County Council Consultation on a Public Toilet Needs Assessment and were mindful of the outcomes of the debate at the Community Meeting held on 6 August 2024 with a clear majority of public sentiment being their wish to see the Public Toilet provision in Llangollen remain as it is.

Cynigiwyd a phenderfynwyd nad oedd y cais yn dderbynol am y rhesymau canlynol:

Mae'r cais yn dweud bod y tir yn wag. Nid yw hyn yn wir. Cadarnhawyd ei fod yn dir amaethyddol. Nododd y Cyngor Tref ym mis Medi 2022 fod apêl wedi ei chyflwyno yn erbyn hysbysiad gorfodi a roddwyd gan y perchenog tir blaenorol i Gyngor Sir Ddinbych. Daeth yr Arolygydd a benodwyd gan Weinidogion

It was proposed and resolved that the application was not acceptable for the following reasons:

The application states the land is vacant. This is not the case. It has been confirmed as agricultural land. The Town Council in September 2022 noted there had been an appeal lodged against an enforcement notice issued Denbighshire County Council by the previous landowner. The Inspector

Nid yw'r datblygiad arfaethedig yn bodloni'r holl feini prawf ym Mholisi PSE 12 – chalet, carafanau a gwersylla statig a theithiol. Yn benodol, mae gan y Cyngor Tref bryderon y bydd yn ymwthiol yn y dirwedd a byddai'n weladwy o'r A539 ac o hawlau tramwy cyhoeddus a safbwytiau o fewn y tirlun cenedlaethol ehangach. Mae safle'r cais yn gorwedd o fewn

Ardal o harddwch naturiol eithriadol ac mae o fewn Safle Treftadaeth y Byd, nid yw'r datblygiad arfaethedig o ansawdd uchel a byddai'n cael effaith andwyol ar y briffordd.

Mae gwybodaeth annigonol wedi'i darparu o fewn y cais mewn perthynas â draenio dŵr budr a draenio dŵr daear.

Mae'r lluniadau cynllun llawr a gyflwynwyd yn dangos darpariaeth cegin, ensuite a twb poeth ar gyfer pob uned. Nid oes dŵr i'r safle. Mae ffynnon a nant naturiol sy'n rhedeg ar draws y tir. Mae'r Cyngor Tref yn tynnu sylw at ei bryderon bod safle'r cais o fewn Ardal Cadwraeth Arbennig Afon Dyfrdwy a Llyn Tegid ac mae'r cynnig yn dangos defnyddio dewis arall yn lle draenio prif gyflenwad.

Rhaid peidio â halogi na tharfu ar y ffynnon naturiol a'r nant a chyrsiau dŵr eraill i lawr yr afon oherwydd draenio budr a llygredd dŵr daear; Mae gan y Cyngor Tref ddyletswydd o dan Adran 6 Deddf yr Amgylchedd (Cymru) 2016 i gynnal a chadw Gwella bioamrywiaeth a hyrwyddo gwydnwch ecosystemau. Mae nodyn Cyngor Technegol 5 (Cadwraeth Natur a Chynllunio) hefyd yn nodi ei bod yn hanfodol sefydlu presenoldeb neu fel

appointed by the Welsh Ministers on 31 March 2023 concluded that the appeal be dismissed and to uphold the enforcement notice ENF/2022/00024 issued on 24 March 2022 requiring cessation of the residential use of this land and to remove the caravans from the land. The proposed development does not meet all the criteria in Policy PSE 12 – chalet, static and touring caravan and camping sites. In particular the Town Council have concerns it will be obtrusive in the landscape and would be visible from the A539 and from public rights of way and viewpoints within the wider national landscape. The application site lies within an area of outstanding natural beauty and is within a World Heritage Site, the proposed development is not of high quality and would have an adverse effect on the highway.

Inadequate information has been provided within the application in respect of foul water drainage and groundwater drainage. The submitted floor plan drawings indicate the provision of a kitchen, ensuite and hot tub for each unit. There is no mains water to the site. There is a natural spring and stream that runs across the land. The Town Council highlights its concerns that the application site is within the river Dee and Bala Lake Special Area of Conservation and the proposal indicates using an alternative to mains drainage. There must be no contamination or disturbance to the natural spring and stream and other water courses downstream due to foul drainage and groundwater pollution; The Town Council has a duty under S6 of the Environment (Wales) Act 2016 to maintain and enhance biodiversity and promote ecosystem resilience. Technical Advice note 5 (Nature Conservation and Planning) also states it is essential that the presence or otherwise of protected species, and the extent that they may be affected by the

Mae gan y Cyngor Tref bryderon difrifol nad oes arolygon ecolegol wedi'u cyflwyno i gefnogi'r cais felly nid yw'n bosibl dangos yr effeithiau ar rhywogaethau a warchodir na dangos y bydd y cynnig yn cynnal ac yn gwella bioamrywiaeth.

Mae'r ymgeisydd yn dywed bydd eu cynnig yn cefnogi Twristiaeth a'r economi wledig leol yn unol â Llywodraeth Cymru TAN 13 (Twristiaeth) a Pholisi'r CDL1 PSE5 (Economi Wledig) Mae'r ddua bolisi hyn yn cydnabod y gall defnyddiau twristiaeth fod yn ymwthiol yn y dirwedd a'r Dylid pwysa a mesur buddion yn erbyn statws arbennig yr AHNE ac a yw'r cynnig yn briodol o ran maint a natur i'w leoliad. Mae cynllun y safle yn dangos dosbarthiad trefol iawn o'r unedau ar lwyfannau uchel gan arwain at ymddangosiad nad yw'n cyd-fynd â'i ardal leol ac na ellid ei ymgorffori'n hawdd yn yr amgylchedd naturiol. Byddai'n weladwy iawn ac yn amlwg yn y dirwedd. Nid oes unrhyw achos busnes wedi cael y cais i ddangos dystiolaeth o'r manteision a fyddai'n helpu i gynnal cyflogaeth leol a'r economi wledig leol.

Codi estyniad deulawr i'r ochr ac estyniad unllawr yng nghefn yr annedd, addasiadau a gwaith cysylltiedig.

Cynigiwyd a phenderfynwyd yn amodol ar yr arsylwadau a nodir isod na ddylid codi unrhyw wrthwynebiadau mewn perthynas â'r cais hwn.

Mae'r Cyngor Tref yn ymwybodol o'i ddyletswydd o dan Adran 6 Deddf yr Amgylchedd (Cymru) 2016 i gynnal a gwella

proposed development is established before planning permission is granted. The Town Council has grave concerns that no ecological surveys have been submitted to support the application so, it is not possible to demonstrate the impacts on protected species nor demonstrate the proposal will maintain and enhance biodiversity. The applicant states that their proposal will support Tourism and the local rural economy as per Welsh Government TAN 13 (Tourism) and the LDP Policy PSE5 (Rural Economy) Both of these policies acknowledge tourism uses can be intrusive in the landscape and the benefits should be weighed against the AONB special status and whether the proposal is appropriate in scale and nature to its location. The site layout plan shows a very urban distribution of the units on raised platforms resulting in an appearance which is out of keeping with its locality and could not be easily incorporated into the natural environment. It would be highly visible and conspicuous in the landscape. No business case has been provided with the application to evidence the benefits that would help to sustain local employment and the local rural economy.

#### **Reconsultation.**

The Town Council therefore recommends that if permission is granted, any building works to this land should be carried out with the agreement of and under the direction of Denbighshire Council's Ecology Officer to minimize impact on biodiversity and prevent excessive lighting and ensure provision of bird and bat boxes and replanting as appropriate.
