Soniodd y Maer am y digwyddiadau diweddar yr oedd wedi'u mynychu, yn cynnwys Gŵyl Nadolig Llangollen, a oedd yn ddiwrnod prysur a phleserus iawn. Manylodd ar ei ran yn y prosesu tractorau gyda'u goleuadau. Fe wnaeth yr olaf godi £10,545.81 ar gyfer ward y plant yn Ysbyty Maelor Wrecsam,

The Town Mayor outlined recent events he had attended which included the Llangollen Christmas Festival which had been a very busy and enjoyable day and detailed his involvement in the illuminated tractor run. The latter had raised £10,545.81 for the children's ward at Ysbyty Maelor Wrexham,

Rhannu Bwyd Llangollen

Cafodd yr Aelodau gyflwyniad gan Steph Mitchell (Rheolwr) a Graham Timms (Cadeirydd) o Rhannu Bwyd Llangollen. Amlinellodd Steph brif amcanion y rhannu bwyd, sef lleddfu tlodi (bwyd yn bennaf) yn ardal Llangollen. Pwysleisiodd yr angen am driniaeth anfeirniadol i bawb a ddaeth. Eglurodd mai hi oedd yr unig reolwr canolfan llawn amser parhaol, gyda 20 o wirfoddolwyr a 4 Ymddiriedolwr yn ei chefnogi. Yn gyffredinol roedd y banc bwyd yn cefnogi 130 o bobl mewn tlodi bwyd, gan drin dros 800 cilogram o fwyd bob wythnos, - pwysau car bychan. Daw'r bwyd yn bennaf o FoodShare Gogledd Cymru a gwarged siopau gan ALDI a'r Co-op, rhoddion gan y cyhoedd, busnesau lleol a chynhyrchwyr bwyd lleol. Ar adegau gwneir pryniannau uniongyrchol yn ogystal. Y diben yw osgoi gwastraff bwyd, sef 2/3 o'r hyn maent yn ei dderbyn. Yn ogystal, maent yn darparu gwasanaethau cyfeirio i nifer o sefydliadau eraill megis y banc tanwydd, Mind, Cyngor ar Bopeth a sefydliadau iechyd. Mae FoodShare hefyd yn cynnig cyfleoedd gwirfoddoli yn arbennig i Ysgol

Llangollen Food Share

Members received a presentation from Steph Mitchell (Manager) and Graham Timms (Chair) of Llangollen Food Share. Steph outlined the main aims of the food share which was relief of (mainly food) poverty in the Llangollen being nonjudgmental of all who came. She explained that she was the one permanent full-time centre manager, and she was supported by 20 volunteers and 4 Trustees. In general the food bank supported 130 people in food poverty handled over 800 kilogrammes of food every week the weight of a small car. Food comes mainly from FoodShare North Wales and shop surpluses from ALDI and the Co-op, donations from the public, local businesses and from local food producers. On occasions it was topped up by direct purchases. The purpose is to avoid food waste which accounted for 2/3 of the food they receive. In addition, they provided signposting services to a number of other organisations such as the fuel bank Mind, Citizens Advice and health organisations. FoodShare also offered volunteer opportunities particularly with

Yr heriau ar gyfer y dyfodol oedd chwilio am adeiladau newydd, sef y prif flaenoriaeth, sicrhau cefnogaeth sefydliadau a busnesau lleol, gwneud ceisiadau llwyddiannus am grant a gwella'u presenoldeb cyfryngau cymdeithasol a thraddodiadol. Ateggodd y cadeirydd yr hyn a ddywedodd Steph a gofynnodd am gefnogaeth Cyngor y Dref i gynorthwyo Rhannu Bwyd Llangollen yn eu hymdrechion i ddatblygu'n sefydliad cefnogi cryf o fewn y gymuned. Yn dilyn cwestiynau a geiriau o gefnogaeth gan yr Aelodau, diolchodd y Maer i Steph a Graham am y cyflwyniad hynod addysgiadol a, gan ddymuno pob llwyddiant i'r prosiect, rhoddodd sicrwydd iddynt o gefnogaeth Cyngor y Dref.

Datganiadau gan Gyngorwyr y Sir.

Darparodd y Cyngor ydd Sir Edwards wybodaeth ynglŷn â chynllun Grant Croeso Cynnes 2024-2025, sef cronfa i sefydlu gofodau presennol neu ar gyfer cefnogaeth er mwyn lles economaidd a chymdeithasol trigolion y gaeaf hwn. Mae grantiau hyd at 5000 ar gael i sefydliadau â chyfansoddiad lleol, - agorodd y ceisiadau ar 12 Rhagfyr a'r dyddiad cau oedd 6 Ionawr, oedd yn anffodus yn amser byr iawn. Cyfeiriodd y Cyng Edwards hefyd ar y gwaith cynnal a chadw sy'n cael ei wneud ar yr A539, gwacáu cwteri ac ysgubo'r ffordd gan ei bod mewn cyflwr brawychus. Lle mae'r CDLL yn bod, roedd y broses bellach wedi cyrraedd Cam 3 a bydd Swyddogion yn anfon llythyrau i hyrwyddo'r safle cyn y Nadolig, gan gyflwyno i Aelodau'r grŵp cynllunio strategol ym mis Ionawr. Daeth y cyfnod ymgynghori cyhoeddus ar y Parc

Ysgol Dinas Bran supporting the Duke of Edinburgh award students, pupils on the Welsh Bacalaureate community service scheme and working with some other more challenging students. The challenges for the future were looking for new premises, which was a top priority, maximizing support from local organisations and businesses, pursuing successful grant applications and improving their social and traditional media presence. The chair reiterated what Steph had said and wished to elicit the support of the Town Council to assist Llangollen Food Share in its endeavours to move forward as a strong support organisation within the community. Following questions and words of support from Members; the Town Mayor, thanked Steph and Graham for the highly informative presentation and assured them that the Town Council were supportive and wished the project every success.

Statements from County Councillors.

County Councilor Edwards provided information re the Croeso Cynnes Grant scheme 2024-2025, a fund to establish existing spaces or support space that support the economic and social well-being of residents this winter. Grants up to 5000 are available for local constituted organisations, - the applications opened on 12 December and the closing date was 6 January, unfortunately such a short time frame. Cllr Edwards also commented on the work being undertaken in the A539 carriageway maintenance, gully emptying and road sweeping as the road was in a shocking state. In relation to the LDP it was now at Stage 3 of the process and Officers would be sending out letters to site promote before Christmas and will present to Members of the strategic planning group of January. The public consultation period on the

Members of the Town Council considered the above applications and adjudged that it was unacceptable in planning terms. Members felt that several of the comments raised during the Town and Country Planning (Development Management Procedure) (Wales) Order 2012 Article 2d consultation were still relevant. Members accepted that the comments raised on the parking provision had been addressed but still felt that there were elements that needed further clarification namely: -

- a) the loss of hotel bed spaces and the potential effect on the local tourist economy which will necessitate the

Members consider the above application and adjudged that, despite some changes, it was unacceptable in planning terms and Members wished to refer to the original comments made on the previous in that the application is contrary to Policy RD 1 - Sustainable development and good standard design, in that the development: -

- a) would have an effect on traffic, access, road safety and parking especially in relation to the adjoining development, Bishops Walk and the junction to the A539.
- b) would have an adverse impact on the appearance of the surrounding areas and adjoining neighbours
- c) due to the scale, and height of the development on the A539 frontage will create a loss of light and overlooking with a subsequent loss of privacy to the properties immediately adjacent to the development on Bishops Walk.
- d) will have an effect on nature conservation through clearance of the

Bishops Walk.

Members of the Town Council considered the above pre planning application and were concerned over a number of issues relating to the application. It was proposed and resolved to comment as follows:-

- a) the fact that the chalet units appeared to have been already stored on the site was felt to be presumptuous and reflected on the sincerity of this consultation.
- b) the proposal also conflicted with to Local Development Plan Policy PSE 12 in that the layout was considered inappropriate. Members believe that the layout could be created that would
