Rhoddodd y Cynghorydd Sirol Edwards ddiweddariad manwl ar nifer o faterion Cyngor y Sir. Y sefyllfa o ran y biniau ailgylchu ac roedd yn hapus bod pethau'n gwella, er bod ambell broblem o hyd ond nid mor broblemus ag y bu yn y gorffennol. Ei ffocws dros yr wythnosau diwethaf oedd cyflwr wyneb y ffordd yn y dref, tyllau yn bennaf a materion draenio. Dywedodd ei bod yn gobeithio derbyn cadarnhad o rywffaint o gyllid ychwanegol ar gyfer gwelliannau i'r ffyrdd, a oedd wedi cychwyn ei hawydd i lunio rhestr o broblemau. Gan fod nifer ohonynt, croesawodd unrhyw gymorth gan aelodau fel y gellid eu hystyried. O ran Stryd y Neuadd, roedd y ffensio ar y maes parcio hwnnw angen sylw ac roedd arwyddion ar y bont wedi'u rhoi ar waith er mwyn lleddfu'r problemau a oedd yn digwydd o ganlyniad i symudiadau bysiau a cherbydau mawr. Dywedodd y Cynghorydd Edwards hefyd wrth aelodau bod yr arian ffyniant cyffredin bellach yn dod i ben ac yn amlwg roedd gwelliannau Parc Glan yr Afon yn rhan o'r cyllid hwnnw. O ran eu prosiect penodol roedd cwpl o bethau y mae angen eu gwneud o hyd i gwblhau'r rhaglen. Roedd y Cynghorydd Edwards wedi mynychu cyfarfod am yr adolygiad o'r cynllun 20 milltir yr awr a chafwyd ymateb ymgynghori isel iawn i ddychwelyd yn ôl i 30mya felly ni welodd unrhyw newidiadau sylweddol yn

Statements from County Councillors.

County Cllr Edwards provided an in-depth update on a number of County Council matters. The situation regarding the recycling bins and was happy that things were improving albeit that there are still a few issues but not as problematic as it has been in the past. Her focus over recent weeks was the condition of road surface in the town chiefly potholes and drainage issues. She advised that she was hoping to receive confirmation of some extra funding for road improvements and that had initiated her desire to compile a list of problems. As there were a number of them, she welcomed any assistance from Members. In relation to Hall Street the fencing on that car park required attention and signage on the bridge had been implemented to hopefully alleviate the problems that were occurring as a result of coach and large vehicle manoeuvres. Cllr Edwards also advised Members that the shared prosperity funding is now ending and obviously the Riverside Park improvements formed part of that funding and in relation to this specific project there were as a couple of things that still need to be done to complete the program. Cllr Edwards had attended a meeting about the review of the 20 mile an hour scheme and there had been an extremely low consultation response to reverting back to 30mph

Llangollen. Mae'r A5 yn fater gwahanol gan mai dyna fydd penderfyniad asiantaeth gefnffyrdd Llywodraeth Cymru. Prif fater cyfarfod y Cyngor Sir oedd ystyried y gyllideb ar gyfer 2025/26. Yr argymhelliad yw cefnogi'r cynllun ariannol tymor canolig sy'n cynnwys cynnydd o 5.29% ar gyfer gwasanaethau'r cyngor ynghyd â 0.71% ychwanegol ar gyfer y cynnydd yn yr Ardoll ar gyfer tân ac achub Gogledd Cymru felly mae hyn yn cyfateb i gynnydd cyffredinol o 6%. Dywedodd y Cyngorydd Keddie wrth yr Aelodau ei fod wedi bod yn cynnal arolwg ac ymchwil helaeth ar Ffordd yr Abaty oherwydd ers blynyddoedd lawer mae'r trigolion wedi bod yn gofyn am disgynnodd i lawr i o leiaf 30 mya. Dywedodd ei fod wedi cyflwyno cynnig i'r Cyngor Sir gyda chefnogaeth y Cyngor Tref ar y sail ei fod wedi gofyn am gefnogaeth, ac ni chefais ateb drwy Glerc y Dref yn erbyn y cynigion.

therefore she did not envisage any significant changes in Llangollen. The A5 is a different matter because as that will be the decision of the Welsh government trunk road agency. The main issue for the forthcoming County Council meeting was the consideration of the budget for 2025/26. The recommendation is to support the medium-term financial plan which includes a rise of 5.29% for council services plus an additional 0.71% for the increase in the Levy for the North Wales fire and rescue so this equates to an overall increase of 6%. Cllr Keddie advised Members that he had been underrating an extensive survey and research on Abbey Road because for many years the residents that have been requesting that it is dropped down to at least 30 mph. He advised that he had submitted a proposal to the County Council with the backing of the Town Council on the basis that he had asked for support, and I got no reply via the Town Clerk against the proposals
